NEW YORK YANKEES TEAM PHYSICIAN AND HEAD TRAINER LECTURE AT NYCPM SPORTS MEDICINE GRAND ROUNDS

Students and faculty at the Medicine were privileged recently to attend a special Sports Medicine Grand Rounds at the College, where they heard lectures by Dr. Stuart Hershon, an orthopedic surgeon who is the Team Physician for the New York Yankees, and by Gene Monahan, the Yankees' Head Trainer. Their visit was arranged by NYCPM alumnus Marc Brenner, DPM, a long-time friend of Dr. Hershon's. The Grand Rounds was made possible by grant from CryoDerm™.

Dr. Hershon discussed foot New York College of Podiatric and ankle issues and injuries he has encountered with Yankees players over the last twenty years. He focused in particular on injuries caused by players fouling balls off their forefoot, and also discussed sprains. He then showed and talked about several cases he had seen of easily-missed fractures of the tarsal navicular, an injury he said was much more prevalent in other sports such as track, basketball, soccer and football. He said athletes with this type of fracture were unable to run with

Three Doctors are Honored for Helping Set Up and Sustain International Programs of Study in Podiatric Medicine

22nd, 2007, the New York College of Podiatric Medicine held an Academic Convocation and Luncheon at the New York Academy of Medicine to salute international cooperation between the College and universities in Spain and Canada that have worked with NYCPM to create programs in podiatric medicine during the last two decades. NYCPM awarded the honorary degree of Doctor of Humane Letters, honoris causa, to three individuals - two from Spain and one from Canada – to acknowledge and honor their efforts leading to the creation and ongoing success of these international programs.

Receiving honorary doctorates were Dr. Marta Losa Iglesias, professor in the Faculty of Health Sciences at the Rey Juan Carlos Public University in Madrid, and Dr. Ricardo Becerro de Bengoa Vallejo, who received his D.P.M. degree from NYCPM in 1995, and is the

Europe with the earned D.P.M. degree. Dr. Becerro de Bengoa was instrumental in setting the program between NYCPM and the Universidad Complutense de Madrid for the training of Spanish podologists in pathology and foot surgery at NYCPM. Also receiving an honorary doctorate was Dr. François Allart, who received his D.P.M. degree from NYCPM in 1993, and was instrumental in founding the program in podiatric medicine at the University of Quebec at Trois-Rivières. The program, which draws on a number of resources at NYCPM, is the first D.P.M. program in Canada, and the first French-speaking D.P.M. program in the world.

The Convocation began with an opening processional of the honorees and the faculty, led by Michael J. Trepal, D.P.M., Vice-President for Academic Affairs and Dean; Maj. Gen. William F. Ward, A.U.S. (Ret.),

explosive speed, a complaint that a doctor would never even hear from the average person. After discussing and illustrating cases he had seen of ruptures of the peroneal longus, and cases of plantar fasciitis, Dr. Hershon concluded by offering general insights into what it was like to be the Yankees' orthopedic surgeon.

Gene Monahan, the Yankees' Head Trainer, recounted a number of anecdotes illustrating his work with the ballplayers. He then devoted the remainder of his lecture to covering four areas - the foul ball bruise, which requires immediate compression; protection of the pitcher's drag foot during the pitching motion; and treatment, from a trainer's perspective, of plantar fasciitis and subungual hematoma.

Convocation concluded with a benediction delivered by Foot Clinics' Board member Rev. Edward Culvert, D.D.

"Each of these three honorees has been instrumental in setting up and sustaining pioneering programs podiatric medical education in their home countries, as well as programs for their fellow countrymen to come and study at NYCPM," said General Ward. "Without the passion of these three individuals for podiatry, and their perseverance in seeking to create international programs of study in the field of podiatric medicine, these programs would likely never have come to fruition."

NEW YORK COLLEGE OF PODIATRIC MEDICINE WELCOMES CLASS OF 2011 WITH ANNUAL WHITE COAT CEREMONY

Lt. Col. Timothy Duffy, D.P.M., Chief of the Podiatry Service At Keller Army Community Hospital, Delivers Keynote Address As First-Year Students Take Initial Step On Road To Becoming Doctors Of Podiatric Medicine, Symbolically Donning White Coat And Reciting Hippocratic Oath

The New York College of Podiatric Medicine (NYCPM) welcomed the students of its Class of 2011 in early September with the College's annual White Coat Ceremony, in which the future Doctors of Podiatric Medicine symbolically don their white coats and together recite the Hippocratic Oath. Lt. Col. Timothy Duffy, D.P.M., Chief of the Podiatry Service at Keller Army Community Hospital, located on the grounds of the United States Military Academy at West Point, delivered the keynote address to the assembled College community and guests.

Lt. Col. Duffy has been Chief of Podiatric Medicine at Keller Army Community Hospital since 2003, also serving in that position from 1996 to 2001. During his Army career, he has also served as a Staff Podiatrist and later Chief of Podiatric Medicine at General Leonard Wood Army Community Hospital, in Missouri, and as Chief of Podiatric Medicine at Guthrie Army Health Clinic, in Fort Drum, NY. Lt. Col. Duffy received his D.P.M. degree from the Ohio College of Podiatric Medicine, and his B.S. degree from Canisius College, in Buffalo, NY.

In both cases, he said, there is total devotion to the ideal of service to others.
