

## **Gregory Rose (2023) Named Winner of 2023 Michael L. Stone Award**

**Gregory Rose (2023)** is the NYCPM winner of the 2023 Michael L. Stone, DPM Outstanding Professional Conduct Award, which is presented by the American Board of Foot and Ankle Surgery (ABFAS). The prize was determined by the NYCPM Scholarship Committee, chaired by Susan Rice, DPM (1988), working in conjunction with the Department of Surgery. Greg is now the National Student Representative for the ACFAS Membership Committee, the only student on the committee, which represents nine of the podiatric medical schools. He is the former president of the NYCPM ACFAS student chapter, and in that role helped to coordinate many lectures and workshops.

Greg is currently pursuing a dual DPM/MPH degree. According to an appreciation by **Matrona Giakoumis, DPM, FACFAS** (2010) an instructor in NYCPM's Department of Surgery, "he represents the highest standard of professionalism, deportment and ethics in his interactions with peers, professors and staff," and he "exemplifies a unique level of discipline, drive and motivation," able to maintain a high level of academic accomplishment while serving in leadership positions. He will receive his award in person at the annual ABFAS meeting to be held in conjunction with the ACFAS meeting in Los Angeles in February.
